Miller has a Bachelor's in Criminal Justice, a Masters in Public Administration, and Masters in Teaching.

Patranya is a TV host, speaker, and media trainer & strategist. A 3 time Emmy award winning broadcast journalist, Patranya has worked as a news reporter/anchor in major news markets across the country including San Francisco, Seattle, Washington DC and Las Vegas.

The Hon. Viengkeo Kay Bounkeua NM State Representative, HD19; NM State Deputy Director, The Wilderness Society

Kay is a first-generation immigrant born to Lao-Chinese parents. She is from Albuquerque, New Mexico and received her Master of Public Health degree from the University of Michigan's School of Public Health. She is the previous Executive Director for the New Mexico Asian Family Center; a board member of Bold Futures NM and the inaugural Chair for ABQ's Office of Immigrant and Refugee Affairs; and is an alumna of the Asian Pacific American Women's Leadership Institute and the W.K. Kellogg Foundation Community Leadership Network fellowship.

In her current role as New Mexico Deputy State Director for The Wilderness Society, Kay has been using her policy, advocacy, public health, program development and movement building experience to advance their work to make public lands a solution to the climate crisis and ensure that all New Mexican's equitably benefit from them.

Kay was recently appointed as the State Representative for House District 19, one of the most diverse districts per capita in the state of New Mexico encompassing Albuquerque's International District. As a freshman legislator, she was able to champion the passage of a language access bill that was recently signed into state law.

In her personal time, she can be found running with her two dogs and exploring the mountains with her husband and three-year-old daughter.

Irene serves on the Planned Parenthood Action Fund Committee and is a leader in the national Asian Pacific Islander American community. She serves on the Asian American Justice Center's National Advisory Council, Asian American Action Fund Board, and previously served on the Board of the Asian Pacific American Institute for Congressional Studies (APAICS). Irene has been recognized for her service to the Asian American and Filipino American communities by the Filipino American Women's Network and the President of the Philippines.

A California native, Irene earned a Juris Doctor from Hastings College of Law and a Bachelor of Arts from University of California, Berkeley. She is a member of the California and District of Columbia Bars and was selected to participate in the Coro Foundation Fellowship Program in Public Affairs in San Francisco, California. An accomplished Latin ballroom dancer, Irene competes at national dance competitions.

Program Manager, Advance Native Political Leadership

April Fournier (Navajo) is the National Program Manager for Advance Native Political Leadership. She supports the development and delivery of the Native Leadership Institute's Leadership Training Program and Native Digital Fellowship.

April has extensive experience in community organizing, community leadership and development, coalition building, and training. April is the co-founder of the first all-Indigenous roller derby team and worked to leverage technology and community building to engage team members globally. She is currently serving as an at-large councilor on the city council in Portland, Maine, the first Native woman to serve in that office. She is a graduate of the University of Maine and holds a degree of Master of Education in Intervention Studies.

April resides with her husband, four children and two dogs in Portland. She enjoys Maine's different seasons, and will swim in the ocean year-round. She also enjoys live music indoors or outdoors, sometimes traveling south to Boston for shows, visiting the many eateries and microbrews around Maine, family game night, beading, and reading science fiction and fantasy novels.



The Hon. Helen Gym *Philadelphia City Councilmember At-Large*

Seated in 2016, Philadelphia City Councilmember Helen Gym leads a human rights agenda which measures outcomes based on the health and well-being of young people in the city.

As Chair of Council's Children and Youth Committee, she has helped lead a public schools agenda that contributed to the end of the 17-year state takeover of the Philadelphia school system, supported funding for pre-K programs, and restored nurses and counselors back to every public school. She established the city's Right to Counsel program to provide legal assistance to low-income tenants facing eviction, as well as the city's nationally acclaimed eviction diversion program. She has also focused her legislative efforts on economic justice issues, including enacting the nations' strongest fair scheduling legislation, and championing expanding the city's living wage laws.

Helen is a former public school teacher and journalist. She currently serves as Co-Chair of Local Progress, a network of progressive municipal leaders, where she has helped lead national efforts around Sanctuary Cities, the DREAM Act, and progressive public education policies. She is the mother of three children and is a graduate of the University of Pennsylvania and the University of Pennsylvania Graduate School of Education.

She is the recipient of a number of awards including the Philadelphia Inquirer Citizen of the Year and the 2017 national Rising Star Award from EMILY's List, the nation's largest organization supporting women in elected office.



Bethany Khan

Spokesperson, Director of Communications & Digital Strategy, UNITE HERE Culinary Workers Union Local 226

Bethany Khan is the Director of Communications & Digital Strategy at the Culinary Union. She uses strategic communications, technology, data, and digital strategy to support working families in Nevada

Bethany is a first-generation daughter of immigrants who overcame many struggles to make sure she had opportunities they never had. Bethany's great-grandmother was an indentured worker from India and both of Bethany's parents were born in Guyana and were young immigrants in the United States of America and undocumented workers until 1986. Because of her ancestor's sacrifices, Bethany was the first in her family of 10 to go to college and graduate with a bachelor's degree.

Bethany graduated with a bachelor's degree in journalism from the University of Minnesota and has used those skills to fight for justice. Bethany has immediate family members who are undocumented and works with the Culinary Union fighting for comprehensive worker-centered immigration reform. As spokeswoman for Nevada's largest union and immigrant organization, Bethany is proud to use her digital and strategic communication skills to support workers in Nevada.

The Culinary Union, Nevada's largest union and immigrant organization, has improved the lives of over 800,000 Nevada hospitality workers and their families with middle-class union wages and good benefits. In 87 years, the Culinary Union has become an essential economic institution and a strong political force in the Battle Born State.

In the past 10 years, Bethany's communications and digital strategy has played a major role in the Culinary Union's campaign, organizing, and electoral work, especially in the last presidential election to defeat Trump.

The Culinary Union delivered Nevada for Joe Biden and Kamala Harris, and Bethany ran a comprehensive strategic communications program to support the largest political effort in state, which included 1.9 million emails and texts, completely in-house polling, digital persuasion social media ads targeting Nevada voters, "Trump Lies" video ads with over 11.4 million views via UNITE HERE's Take Back 2020 PAC, and uplifted the stories of workers who are fighting to take back their country. In 2020, the Culinary Union, under Bethany's leadership and direction, had over \$625 million unique earned-media stories uplifting directly impacted and frontline essential hospitality workers' voices that were featured in international, national, and local media markets.

Awards, recognitions, and nominations: Bethany was honored as a Trailblazer at the Asian

Community Development Council's InspirAsian Gala in 2021, distinguished as a "40 under 40" award recipient at the American Association of Political Consultants in 2018, recognized on the National Association of Asian Pacifics in Politics & Public Affairs "40 under 40 List" in 2018, was named one of Vegas INC's "Women to Watch" in 2016, was nominated as a High Tech Woman of the Year in 2015 in the Vegas Women Tech Awards, and was proudly a World Food Championships Judge in 2014.



The Hon. Nima Kulkarni Kentucky State Representative, 40th Legislative District

In 2018, Nima Kulkarni became the first Indian immigrant to be elected in the history of the Kentucky Legislature. She has also managed her own immigration law practice since 2010, helping others achieve the American Dream. Nima has dedicated her time as a public servant to helping the most vulnerable Kentuckians. She has been able to stop harmful anti-immigrant legislation, as well as gain bipartisan support for a historic bill that would ensure a fair and equitable judicial process for all Kentuckians.

In 2019, Nima was asked to serve as the only Democratic legislator on the Public Assistance Reform Taskforce. She was the first legislator from Kentucky to be invited to join the 2019 U.S.-Japan Council's Asian American Leadership Delegation program, one of just six (6) legislators asked to participate from across the country. She was also honored to be the first woman from Kentucky named as a NewDEAL Leader, a national group of rising state and local elected leaders who are pro-growth progressives.

In 2020, Nima was named as one of a handful of Louisville leaders to serve on the Mayor's Civilian Review Board Working Group, to achieve greater transparency, accountability, and trust between the community and law enforcement in the wake of Breonna Taylor's death. She continues to work on crafting comprehensive police reform legislation for Kentucky.

In 2021, Nima was recognized as a NewDEAL Ideas Challenge Winner for her work with the Kentucky Maternal and Infant Health Project. She was awarded the Daniel M. Alvarez Champion of Justice Award for her social justice work and for bringing our community together in calling for an end to racial and ethnic stereotyping amidst the rise in hate crimes against Asian Americans. She also cofounded a podcast called "Where Y'all Really From", to showcase Asian American stories in Kentucky.

Nima is focused on issues of economic, social, racial, and environmental justice for all Kentuckians. Most recently, she has sponsored legislation to decriminalize and fairly regulate adult cannabis use, establish a uniform bodycam policy for law enforcement, extend unemployment to domestic violence/stalking/sexual assault victims, create more equal footing between landlords and tenants, update and strengthen Kentucky's hate crime laws, and monitor and regulate "forever chemicals" in Kentucky's drinking water. Nima is the Kentucky State Lead for the National Council of Environmental Legislators, and represents Kentucky on a new nationwide task force to combat "Shoot First" laws.

She is a progressive voice for her district, and works with colleagues on both sides of the aisle to create policy that empowers Kentuckians. Nima serves on the House Standing Committees on Judiciary, Economic Development, Agriculture, and Banking & Insurance. She is a member of the House Democratic Women's Caucus, the Kentucky Nonprofit Caucus, the Louisville Metropolitan Caucus, and of course, the Bourbon Trail Caucus.



Christina KuoSenior Strategist, Grassroots Solutions

Christina Kuo is a Senior Strategist with Grassroots Solutions based in Michigan. She brings over 18 years of advocacy, civic engagement, and campaign experience into her work with clients to help them better understand and expand the impact of their civic engagement and public engagement work through strategy development and evaluation.

Prior to joining Grassroots Solutions, Christina was the State and Local Campaigns Manager for the U.S. Green Building Council, where she worked with members of USGBC's state-based chapters to develop strategic grassroots and grasstops advocacy programs in key states. In addition, she educated and directly lobbied policymakers in state legislatures and at the local government level on energy efficiency related policy and green affordable housing. Before USGBC, she was the Deputy Political Director at OFA Michigan for President Obama's 2012 reelection campaign working with political and celebrity surrogates to educate voters about President Obama's achievements, as well as organizing the Michigan Women for Obama volunteer and voter outreach effort.

She began her career in issue advocacy and campaigns, while at the University of the Michigan, as a community organizer for reproductive rights. She has worked on numerous advocacy campaigns on campaign finance reform, redistricting, and issues concerning the nonprofit sector that have bridged community organizing, grassroots advocacy, civic engagement, and legislative lobbying strategies.

She holds a law degree from Thomas M. Cooley Law School in Michigan, with a concentration in administrative law, and is a licensed attorney in Michigan. She received her B.As. in Political Science and Women's Studies from the University of Michigan, Ann Arbor. She was named to the 2017 40 Under 40 for the National Association of Asian Americans in Politics and Public Affairs.



Vida Chan LinPresident and Founder,
Asian Community Development Council

Vida Chan Lin has worked closely with the Las Vegas Asian American and Pacific Islander (AAPI) community for the past 26 years. She currently serves as the founder and president of the Asian Community Development Council (ACDC), the first and only non-profit community development corporation in Nevada established to educate, connect and empower the fastest growing demographic in the United States.

Through the creation of ACDC, Ms. Lin has created a space for vital resources for the AAPI community. She developed the first Asian food pantry in Nevada, providing culturally appropriate food that meets the dietary needs of AAPI as part of the first steps to tackle food insecurity. She has created both COVID-19 and flu pop-up vaccination clinics with the goal of serving individuals with limited English proficiency. ACDC also assists with health insurance enrollment, free citizenship assistance, translation, and voter registration. ACDC hosts College Readiness Bootcamp, GraduAsian, Asian Night Market, Asian Small Business Week, among others.

The Honorable Chanpone Sinlapasai was appointed to the Multnomah County Circuit Court by Governor Kate Brown and was sworn in as a circuit court judge on September 20, 2021. She is assigned to the court's general trial docket, presiding over both civil and criminal matters.

Judge Sinlapasai was born in Laos and came to America as a Refugee in 1980. She was resettled in Stockton, California and was raised in Northern California. She earned her Bachelor of Arts in English and Philosophy from Santa Clara University in 1998. She earned her J.D. from Northwestern School of Law at Lewis & Clark College in May 2002. She began her legal career as an advocate for victims of crime and violence at Immigrant Refugee Community Organization and Catholic Charities. She later became an Associate for the Law Office of John Marandas. She became a member and partner of Marandas Sinlapasai Garcia, LLC.

Judge Sinlapasai's legal practice focused on cases involving the protection of victims' rights throughout the immigration process. She represented clients in removal defense proceedings and assisted in her client's cases both in the federal and state criminal justice systems. She founded programs to assist immigrant and refugees, such as Refugee Adjustment Day (RAD), citizenship workshops, and know your rights clinics in partnership with community partners and specialty bars. As an attorney she tirelessly advocated for the community, especially marginalized communities throughout the litigation system.

Judge Sinlapasai is a past chair and commissioner of the Oregon Commission on Asian Pacific Islander Affair, Board member of Oregon, American Civil Liberties Union, Past chair and board member of the Immigrant Refugee Community Organization, Federal Bureau of Investigation Citizens Academy and the Federal and State task force on Anti-Human trafficking team. As an attorney, her firm was a member of the Mexican Consulates Protection Team. Judge Sinlapasai is a member Oregon Women Lawyers (OWLS), Oregon Pacific Asian American Bar Association (OAPABA), Oregon Minority Lawyers Association (OMLA), and Multnomah Bar Association (MBA). Judge Sinlapasai speaks at continuing legal education seminars for the Oregon State Bar, the U.S. Attorney's Office, Oregon Department of Justice, Oregon's specialty bars, and State and Federal Law Enforcement, to name a few.

Outside of the court, Judge Sinlapasai loves spending time with her family, hiking, reading books, and cooking with her family.



The Hon. Pat Spearman Nevada Senate, District 1

Dr. Pat Spearman is an American cleric, veteran, and Democratic politician from North Las Vegas, Nevada. She was elected in November 2012 to the Nevada Senate representing District 1, that is composed of the northern section of North Las Vegas and slivers of neighboring jurisdictions, after defeating the incumbent in the primary, and winning the general election. Spearman became the first openly lesbian member of the Nevada Legislature. She was re-elected in November 2016, and serves as co-majority whip since. Sher is regarded as one of the most liberal members of the Nevada Senate. In 2017, Dr. Spearman introduced and was instrumental to the passage of a resolution to ratify the Equal Rights Amendment (ERA), making Nevada the 36th state to vote to ratify the 1972 ERA. She has introduced bills that provide equal pay for women, support LGBT rights, and support veterans. Moreover, she was involved in the process of establishing the Nevada Revenue Plan during the 2015 session. On October 6, 2021, Spearman entered the 2022 race for Mayor of North Las Vegas, Nevada.

Before being elected senator, Spearman served in the United States Army for 29 years, reaching the rank of lieutenant colonel, was a pastor, and held several public service positions, including president of the school district of San Marcos, Texas.

Dr. Spearman holds several accredited degrees; a Bachelor of Science (BS) in Political Science from the Norfolk State University, Norfolk, VA; a Master of Divinity (M.Div.) from The Seminary of the Southwest; and a Doctorate of Business Administration (DBA) from Walden University.

Dr. Spearman is an Ordained Minister, former Pastor, and serves on the Global Social Justice Ministry Team of The Fellowship of Affirming Ministries, Retired Lieutenant Colonel (U.S. Army), former part-time lecturer at the University of Louisville, and a Nevada State Senator representing Senate District 1.

Dr. Spearman has served as Chair of the Committee on Legislative Operations and Elections, Vice Chair of Government Affairs, member of Revenue & Economic Development, Commerce Labor & Energy, Health and Human Service, and Transportation committees in the Nevada State Legislature. She also serves as the Chair of Active Military and Veterans Affairs subcommittee for the Counsel of State Governments, member of the Energy Resource Task Force, and the Natural Resources and Infrastructure Committee of the National Conference of State Legislators Her doctoral study, Using Sustainable Development as a Competitive Strategy, provided her the opportunity to gain professional and academic expertise to facilitate improvements in the rural electric industry.

Dr. Spearman is also an active member of the Alpha Kappa Alpha Sorority. She enjoys, travel, learning about different cultures, music, and spending time with her family.



The Hon. Sheng ThaoOakland Council President Pro Tempore

Councilmember Sheng Thao (District 4) was elected in 2018, and currently serves as Council President Pro Tem. She is a daughter of Hmong refugees, and a domestic violence survivor, who was homeless for a time as a young mother. She went on to graduate as valedictorian from Oakland's Merritt College, transferring to UC Berkeley where she helped co-found the Bear Pantry.

She joined the City Council staff and later became the first Hmong-American woman Councilmember in California history. Sheng brings her tenacity, creativity and perseverance to lead Oakland at this critical time.

She has been recognized for her leadership and ability to unite stakeholders and received the 2021 Powerful Women of the Bay Award, and was honored by the Alameda Labor Council as a champion for working families. Her candidacy has united organized labor, community leaders, elected officials and big and small business.

Earlier in her career, Dr. Wong also was the first Asian American to serve as School Principal in the State of Texas and to also serve as Associate Superintendent in HISD.

Dr. Wong is a recognized leader in both the Asian American and the greater Houston Community. She currently serves on the Boards / Advisory Boards University of Texas Health School of Medical Bio Informatics, the Texas Library and Achieves Commission, the Asian Pacific American Heritage Association (co-founder), and the Texas Asian American Assembly (founder and past chair). She also served as the Vice President of the Houston Chapter of the American Leadership Forum, the Houston Olympic 2012 Foundation, the Chair of the South Central Region Arthritis Foundation and the Texas Arthritis Foundation, Greenway Council of Homeowners, and the Memorial West Republican Women's Board.

She has been recognized for community service and dedication by the Greater Houston Women's Foundation, the Houston Lion's Eye Bank, the National Conference of Christian and Jews, the Texas Asian Republican Caucus, the Young Women's Christian Association, the Upper Kirby District, TREK, the Texas Council of Women School Executives, the Chinese Community Center, the Variety Children's Charity, Greater Houston OCA, The University of Texas at Austin's Community Leadership Circle, the National Chinese American Citizen's Alliance, the Asian Network Association, and the Asian Pacific American Heritage Association with the George H.W. Bush Award for Service. In 2020, Governor Abbot appointed her as the Chair of the Texas Library and Archives Commission. In March 2022, KPRC, Channel 2, Houston, chose Dr. Wong as one of "14 Trailblazing Women who left a lasting mark on Houston and Beyond."

Dr. Wong earned a Bachelor degree from the University of Texas and a Masters and Doctorate from the University of Houston, where she has also been recognized as a Distinguished Alumnus by the University of Houston Alumni Association and the UH College of Education Alumni.
