She has also worked to reform mental health and substance abuse care, and expand the use of telehealth, and ensure equitable access to quality care.

Representative Ami Bera is the CAPAC Executive Board Member and CAPAC Healthcare Task Force Co-Chair and has represented California's 6th Congressional District since 2013. He is a member of the House Foreign Affairs Committee, the House Permanent Select Committee on Intelligence and the Select Subcommittee on the Coronavirus Pandemic. Prior to his term, he served as Chief Medical Officer for Sacramento County and a clinical professor of medicine and associate dean for admissions and outreach at University of California, Davis.

Representative Pramila Jayapal represents Washington's 7th District and is currently serving her fourth term in Congress. Jayapal is an Executive Board Member of CAPAC. In office, Jayapal works to pass legislation to address healthcare issues as the lead sponsor of the Medicare for All bill in the House.

# Representative Lucy McBath

U.S. House of Representatives, GA-07

Representative Lucy McBath represents Georgia's 7th Congressional District. Rep. McBath is an Associate Member of CAPAC. Rep. McBath works to ensure that all Americans have access to quality, affordable care. In 2023, she partnered with Senator Warnock to introduce a bill that would cap insulin costs at \$35 a month for seniors on Medicare. Rep. McBath has also supported H.R. 1425, the Patient Protection and Affordable Care Enhancement Act, and introduced legislation requiring Medicare to cover hearing aids.



# Representative Young Kim

U.S. House of Representatives, CA-40

Representative Young Kim represents California's 40th District. In the House of Representatives, she serves on the Maternity Care Caucus. Past legislation introduced by Rep. Kim includes the bipartisan Health Communication Access and Resources for Everyone (Health CARE) Act (H.R. 5762) to reduce barriers to health care access for patients.



# Representative Jill Tokuda

U.S. House of Representatives, HI-02

Representative Jill Tokuda represents Hawai`i's 2nd Congressional District. Congresswoman Tokuda is a Freshman Representative of CAPAC. She funded the Hawai`i Keiki Program to provide access to health services in public schools. Jill is also a founding member of the Patsy T. Mink PAC, a political action committee that supports pro-choice women seeking elected office. During the pandemic, Jill was appointed to the Hawai`i House Select Committee on COVID-19 Economic and Financial Preparedness.

Jackie Leung, PhD, JD, MS
Executive Director, Micronesian Islander Community

Jackie is the Executive Director of the statewide nonprofit, the Micronesian Islander Community (or MIC), and is an Assistant Professor at Linfield University. Jackie's background is in public health advocacy, policy, and research. Her work includes working in Medicaid, healthcare access, chronic diseases, COVID-19 wrap-around services, and leadership pathways for community health workers. She serves in several leadership positions, including co-chairing the Commission on Asian and Pacific Islander Affairs and serves as a traditional health worker representative on the Oregon Maternal Mortality and Morbidity Committee. She is a Public Voices Fellow of AcademyHealth in Partnership with The OpEd Project.



Viet Nguyen, MD
Medical Director, Research and Development, Biogen

Dr. Nguyen is a Medical Director in R&D at Biogen, where he focuses on high-burden genetic neurodevelopmental disorders, epilepsy, and neuropsychiatry, as well as measurement and endpoint development for clinical trials, and inclusive patient-focused drug development. This includes leading the creation of Biogen's toolkit for the diverse representation of participants in multi-regional clinical research, based on the latest academic evidence and guidance. His patient care and academic work as Clinical Associate Professor of Neurology at Stanford University includes intraoperative neurophysiology, clinical outcomes research, and medical education and mentorship. He completed his medical degree at Chicago Medical School (Rosalind Franklin University of Medicine and Science), his neurology residency and clinical neurophysiology fellowship at Stanford University, and is board-certified in Neurology, Clinical Neurophysiology, and Neurophysiologic Intraoperative Monitoring.



Maile Tauali'i, PhD, MPH
Collaborative Investigator, Hawaii Permanente Medical Group

Maile Tauali'i, PhD, MPH, serves as an assistant clinical investigator for HPMG, or Hawaii Permanente Medical Group, the state's largest multispecialty group practice. Dr. Tauali'i joined HPMG in 2018, in which she worked with CIHR on the utility and validity of health information for racial minorities. Her research focused on eliminating health disparities, specifically for Indigenous Peoples and Native Hawaiians. Dr. Tauali'i serves as a resource to HPMG physicians, providers, and staff in areas of research, cultural safety, and working in partnership with communities of Hawaii, especially to the Native Hawaiian population, as the first people of Hawaii. In 2015, Dr. Tauali'i established the world's first global Indigenous Master of Public Health degree program and was awarded the University of Hawaii, Board of Regents Excellence in Teaching Award. Her federal commitments include serving as a member of the National Advisory Committee on Racial, Ethnic, and Other Populations, U.S. Census Bureau, a member of the National Institutes of Health, PhenX Working Group on Social Determinants of Health, and the All of Us Research Program Biospecimen Access Policy Task Force.

#### Adam Carbullido

Director of Policy and Advocacy, Association of Asian Pacific Community Health Organizations

Adam P. Carbullido is the Director of Policy and Advocacy at AAPCHO, an organization dedicated to promoting advocacy, collaboration, and leadership that improves the health status and access of Asian Americans (AAs), Native Hawaiians, and Pacific Islanders (NH/PIs). AAPCHO envisions a world in which AAs, NH/PIs, and all communities have equitable access to affordable, high quality, and culturally and linguistically proficient health care.

Adam is responsible for developing and implementing the AAPCHO's legislative and regulatory strategy and leads the organization's engagement with Members of Congress, administration officials, national partners, and community stakeholders to advance policies that improve health access and outcomes of AAs, NHs, PIs, and the community health providers that serve them.



## Paulo Pontemayor, MPH

Senior Director of Government Relations, Catholic Health Association

Paulo G. Pontemayor currently serves as Senior Director of Government Relations for the Catholic Health Association of the United States (CHA), the national leadership organization of more than 2,200 Catholic health care systems, hospitals, long-term care facilities, and other health organizations—the largest group of nonprofit health care providers in the nation. He also serves as Chair Emeritus for the Partnership for Medicaid, made up of organizations representing clinicians, health care providers, safety-net health plans and counties whose goal is to preserve and improve the Medicaid program. Prior to CHA, he has worked at The Joint Commission, the U.S. Department of Health and Human Services, the Asian & Pacific Islander American Health Forum, and as an aide for several members of the U.S. House of Representatives. Paulo has an Executive Certificate in Healthcare Leadership and Patient Safety from Georgetown University, a Master of Public Health degree from the Milken Institute of Public Health at the George Washington University and an undergraduate degree from the University of Washington in Seattle. A believer in lifelong learning, Paulo is currently pursuing his Doctorate in Public Health from the Johns Hopkins University Bloomberg School of Public Health, where he is a Health Equity scholar. He was named a Top 40 under 40 healthcare leader by the National Minority Quality Forum and has been recognized as a Top 100 Lobbyist for several years by the National Institute for Lobbying and Ethics. Originally from the U.S. territory of Guam, Paulo continues to draw strength from his Filipino immigrant family, starting with his grandfather who came as a contract laborer after World War II to help rebuild the war-torn island, as an inspiration for his policy work.

## Lan Đoàn, MPH, PhD (Moderator)

Assistant Professor in the Department of Population Health, Section for Health Equity, NYU Grossman School of Medicine

Lan N. Đoàn is an Assistant Professor in the Department of Population Health, Section for Health Equity at NYU Grossman School of Medicine. She is a social epidemiologist with training and applied experience in conducting community-based participatory research (CBPR) working with racially and ethnically diverse, low-income, and limited English proficient communities. Her research examines populations of older adults, with a particular focus on Asian American and immigrant older adults and how neighborhood environments modify determinants of health across the life course. Dr. Đoàn also works in close partnership with Native Hawaiian/Pacific Islander community partners and serves as a Trusted Scientist for the Resource Network for the Native Hawaiian/Pacific Islander Data and Research Council. These interests reflect her personal commitment to promoting health equity in research and mentorship for historically marginalized and underrepresented populations.

She serves on the Resources Centers of Minority Aging Research (RCMAR) National Coordinating Center Scientific Advisory Board and was previously an Associate Fellow at the University of Pennsylvania Leonard Davis Institute for Health Economics. Dr. Đoàn completed a postdoctoral fellowship in the Department of Population Health at the NYU Grossman School of Medicine and earned a BA in Integrative Biology and Asian American Studies from the University of California, Berkeley, MPH in Community Health and Education from Touro University California and PhD in Health Promotion and Health Behavior with a minor in Biological Data Science from Oregon State University.

Anna Hing, PhD
Research Scientist, University of Minnesota

Anna Hing is a post-doctoral associate at the University of Minnesota in the Department of Health Policy and Management and at the Center for Antiracism Research for Health Equity. There, she is working with Dr. Rachel Hardeman on projects related to the operationalization and measurement of structural racism. Prior to this, Dr. Hing completed her doctorate at the University of California, Los Angeles in Public Health. Her dissertation sought to understand how voter suppression policies as a form of structural racism may contribute to racial disparities in infant outcomes and life expectancy. In congruence with this work, she has proposed a framework through which voter suppression may act as a determinant of health. Her research has also investigated the impact of discrimination on health, from examining experiences of vigilance to the increase in racialized, discriminatory language during the COVID-19 pandemic. Lastly, Dr. Hing has studied health and immigration; specifically exploring how the visa process in the United States stratifies health for Filipino migrant. She will continue to pursue research that elucidates the mechanisms linking voter suppression and health.



James Huỳnh, MA, MPH Incoming Assistant Professor, University of Michigan

James Huỳnh (he/him/his) is the son of Vietnamese refugees who come from Huế, Việt Nam. James is an incoming assistant professor of anti-racist health policy in the Department of Health Management & Policy at the University of Michigan and currently a PhD candidate in Community Health Sciences at the UCLA Fielding School of Public Health. His scholarly and activist commitments are addressing the health impacts of racial capitalism, heterosexism, and patriarchy among queer and trans Asian/Americans. He focuses on community well-being, family and kinship, and grassroots organizing as paths to transforming systems of power. Prior to graduate school, James was a Fulbright Fellow in Việt Nam. James also serves as the Research Committee Co-Chair for Viet Rainbow of Orange County (VROC), a grassroots organization that builds community and mobilizes intergenerationally primarily with LGBTQ+ Vietnamese Americans and their loved ones through research, education, and advocacy. He previously served as VROC's board chair. James earned his MA in Asian American Studies and MPH in Community Health Sciences from UCLA and a BA in Human Biology from Stanford University.

Associate Professor of Surgery, City of Hope

Yanghee Woo, M.D., is an internationally recognized surgeon-scientist with expertise in robotic surgery and gastric cancer. As a leader in her field, Dr. Woo has dedicated her unique perspective, training, and expertise to bring the best of surgical innovation and medical discoveries to transform the cancer care of her patients and cancer patients worldwide. Dr. Woo has been awarded the "Illuminator Award" by Hope for Stomach Cancer for her visionary work in stomach cancer and the "Community Leader in Medicine Award" by the Korean American Federation of LA for her efforts to eliminate disparities in cancer care in our communities.



Michele Wong, MS, PhD

Michele J. Wong, MS, Ph.D., is a Postdoctoral Scholar with the Initiative to Study Hate, housed in the Division of Social Sciences at UCLA. She earned her Ph.D. in Social Welfare at the University of California, Los Angeles. Dr. Wong's research explores how hate fuels and perpetuates racism, and the complex ways hate operates at the intersection of gender and race. Specifically, her work focuses on (a) protective and risk factors for health and mental health outcomes among Asian American women, (b) intersectional stressors associated with work and health inequities, and (c) development of culturally relevant interventions that address intersectional stressors, particularly gendered racial microaggressions among Asian American women, at multiple levels.

Adrian Matias Bacong, PhD, MPH is a Center for Asian Health Research and Education (CARE) postdoctoral research scholar within the Stanford University School of Medicine - Division of Cardiovascular Medicine. Dr. Bacong is also a current T32 Postdoctoral Scholar in the Division of Endocrinology at the Stanford University School of Medicine and is a postdoctoral affiliate of the Center for Innovation in Global Health. Dr. Bacong's current projects evaluate the utility of racial correction factors in cardiovascular risk algorithms, such as pooled cohort equations. This project is funded through the American Heart Association. His research also explores the intersections of immigration and structural racism on health, specifically among Asian individuals.

His work has been published in the Journal of Epidemiology and Community Health, Journal of Health and Social Behavior, and Social Science and Medicine - Population Health. Dr. Bacong graduated with this PhD in Community Health Sciences from the UCLA Fielding School of Public Health in 2022 and received his MPH in Health Promotion and Behavioral Science from the San Diego State University School of Public Health in 2016.
